#### **Minutes**

### 1. Welcome

## 2. Minutes of the last meeting

The 200 club monthly payout figure in the last minutes was incorrect - it should have been £64, not £84. Otherwise the minutes were agreed.

## 3. Finances

There is currently a balance of £3826.17 in the bank account, including the 200 Club payments in from parents at a total of £1656.00. Fulford School has raised 2 invoices for previously agreed funding totalling £1278.72, leaving a balance in the bank of £2547.47. Once the 200 club monthly draws are complete, the balance will be approximately £1747.00.

#### Uniform

Fiona Phillips has kindly agreed to take on the uniform co-ordinator role. This is an important service to parents and the school. Any funds raised will go to the PTA until its dissolution; after that directly to the school's discretionary fund. Fiona has helpfully organised current uniform stocks, which includes a mix of some new style and legacy uniform. It was agreed that the legacy uniform can now be recycled as there is no need for it in the school. ## 200 Club

# 4. Resolution to dissolve the PTA (see PTA constitution 13.1)

Helen proposed the following resolution:

To dissolve the PTA with effect from August 2023; to pay out 200 club to the end of the school year and any other outstanding amounts promised to the school; to distribute remaining assets to the school for the benefit of the pupils of the school.

The reason for proposing this resolution is that no new volunteers for committee positions were forthcoming at the AGM or since, and Helen is standing down as chair. According to the constitution at least 2 trustees are required. The PTA's income has also been significantly reduced due to the change of uniform and COVID stopping fundraising events.

The resolution was agreed unanimously. The bank account will continue to run until the end of the school year to allow for any money to be collected; the remaining balance will be distributed to
